## 1.0 Guest Introductions

### 1.1 Overview of Muskoka River Water Management Plan and how it affects Moon River (presentation by Steve Taylor)

- Signatories to the plan
- Explained: What is a WMP? Why prepare a WMP?
- 41 structures on Muskoka watershed; 29 MNR & 11 power producing, 1 other
- Discussed issues to be considered in formulating a WMP

### 1.2 (Dave MacPherson) Review of past management practices and rationale for why particular manipulations are made in accordance with the current plan.

- Discussions regarding 2009/08/07/06 manipulations – how it worked; what

decisions were made and why; what could have been done differently.

### 1.3 Future communications:

- Need to plug some data gaps – set spawning date criteria
- Bracebridge water control staff are willing to meet pre and post-freshet to review conditions in the watershed and discuss water control manipulations
- (Trevor Griffin) Water control staff willing to work with EGBSC to formulate a decision tree for water control manipulations in accordance with a multitude of freshet scenarios.
- **ACTION: The EGBSC unanimously supports this proposal of a decision tree and will fully cooperate in its formulation. Bracebridge water control staff to lead this initiative.**
- Education of upstream stakeholders is key to maximizing flexibility within the current WMP to improve flow conditions for downstream walleye production. Discussion: Perhaps the EGBSC should lead an 'information open house' in Bala to pursue this public awareness theme. **Action: This matter to be further discussed by the EGBSC for inclusion in work plan.**

- 2.2 Action: Eric to contact TROOP with offer to pay expenses related to Crown Land clean-up activities. (Done.)
- 2.3 Resolution: The EGBSC is pleased to donate \$200 towards the Kapikog Lake Cottage Association workshop and Fun Day. (Done)
- 2.4 Action: Eric to contact UGLMU and report back on rationale re Limestone Islands lake trout stocking program. (Done. Response from Dave Gonder in handout package to Council)
- 2.5 Some concern expressed by Council members re May 15<sup>th</sup> letter re Aboriginal Conservation Office in Parry Sound. Eric to send letter out to Council for future discussion. (Done. Letter and response in Council handout package for later discussion at this meeting. See item 6.1)
- 2.6 Action: Eric to notify Rob Gibson relating to a complaint received by Council in the matter of no response from MNR to an infraction reported via the TIPS hotline. (Done)

## 3.0 Updates:

- 3.1 Stewardship Ranger Crew

- Andrew McLellan – Crew Leader now hired on (started June 15)
  - 4 rangers: Eric Root / Michael Clark / Tori Nesbitt and Breanne Haskin to start June 29<sup>th</sup>
- 3.2 2009 Lake Stewardship Workshop – delivered June 22 @ Stockey Centre, Parry Sound
- 61 attendees representing 19 cottage associations + conservation / G&F clubs
  - Also DFO & GBBR set up information tables (our thanks to them for participating)
  - Presentations will soon be posted on website (*posted June 25<sup>th</sup>*)
  - Eric: At a future meeting – suggest we review our delivery of this project. Workshop popularity has ‘plateaud’; attendance somewhat disappointing
  - *Supplemental: Expenses for workshop – approx. \$1k; donations received \$185.*
- 3.3 Go Home Bay Walleye Rehabilitation (Re-introduction) Project
- Currently awaiting EA screening designation before proceeding
  - Have contacted MGS (Andrej Baca) to commence procurement but cannot proceed until above completed
- 3.4 Regional Economic Development – Fisheries Rehabilitation Action Plan (i.d.NOR)
- Ivan currently in the process of securing partner support for project
  - Memo previously circulated by e-mail updating progress was included in handout to council
  - Intend to have Ivan attend our next meeting to give a wrap-up presentation of Phase 1 for which he is contracted for. Phase 1 ends July 31<sup>st</sup>.
- 3.5 Clean-up day for McCrae Lake:
- Conducted May 31<sup>st</sup>
  - Partners: Barrie Canoe Club, Twp. Geo. Bay, MNR, EGBSC
  - Generally speaking – delighted with the low amount of garbage collected; took ½ ton load to Baxter transfer station
  - Previous activities by TROOP contributed to good condition of campsites.

  - Letter from 'Office of the Great Lakes – State of Michigan', addressed to 'Ontario First Nations'; requesting comments regarding proposal to withdraw water from Lake Huron for domestic water supply of in various municipalities. Item informational; no action required.
- Response from Lois Deacon (Director of Enforcement Branch) in reply to our letter of May 15 re Aboriginal Conservation Officer in Parry Sound.
  - Copy in handout to Council
  - Response is non-committal.
  - Noted by Gerry that Aboriginal officer should be in addition to current compliment of officers.

### 6.2 Request from Bob Duncanson (GBA Executive Director) for EGBSC to endorse GB-5 Statement of Intent.

- Statement read
- Resolution: EGBSC is in agreement with and supports the above statement. Carried.

### 6.3 Synopsis of Moon River walleye population re Minister's visit – July 9<sup>th</sup>.

- Noted there is some angst within MNR that this synopsis represents lobbying the Minister
- Discussion:
  - Synopsis is not offensive or derogatory of the MNR in any way, in fact it notes their significant contribution to rehabilitation
  - If it does constitute lobbying – it is for the benefit of the resource
  - 2 modifications made to synopsis – all in agreement
  - Present synopsis as modified to Minister – carried.
